The **2017-18** recipients are:

Andrea Crowell, MD

Dr. Crowell is an Assistant Professor, Department of Psychiatry and Behavioral Sciences, Emory University School of Medicine. She will develop an educational tool using simulated patients to teach residents/students how to manage agitated behavior.

Alauna Davis Curry, MD

Dr. Curry is an Assistant Professor, Department of Psychiatry and Behavioral Sciences, Baylor College of Medicine/Michael E. DeBakey VA Medical Center. She will develop an educational product to facilitate evaluation of attitudes about race and racism and provide evidence-based practices to help effectively address racism within clinical practice.

Jeffrey Rakosky, MD

Dr. Rakosky is an Assistant Professor and Director of Medical Student Education, Department of Psychiatry and Behavioral Sciences, Emory University School of Medicine. He will develop a computer-generated, standardized, patient care simulator to assess residents' psychopharmacology knowledge.

Ruth Shim, MD, MPH

Dr. Shim is Associate Professor, Department of Psychiatry and Behavioral Sciences, University of California Davis School of Medicine. Her project involves educating psychiatrists to identify the role of social determinants that contribute to mental illnesses and disparities and providing them with essential tools to effect change in their patients and communities.

Jonathan H. Smith, MD

Dr. Smith is an Assistant Professor and Adult Residency Program Director, Department of Neurology, University of Kentucky College of Medicine. He is exploring the use of unannounced simulated patients to evaluate neurology residents' communication and interpersonal skills.

Shilpa Srinivasan, MD

Dr. Srinivasan is an Associate Professor and Associate Director of Geriatric Psychiatry Fellowship Training, Department of Neuropsychiatry and Behavioral Science, University of South Carolina School of Medicine. She is developing and implementing an online curriculum to train psychiatry residents in motivational interviewing to enhance the care of patients with substance use disorders.
