Dr. Bodensteiner serves on the Executive Committee of the Southern Pediatric Neurology Society (SPNS) and is the editor of the

SPNS *Case Studies Issues*. He is the Founding Editor of the *Seminars in Pediatric Neurology*.

Dr. Bodensteiner succeeds Paramjit T. Joshi, MD, Professor and Interim Chair of Psychiatry and Human Behavior at the University of California in Irvine, CA.
